# Nod to land acquisition for riverside road

The Pune Municipal Corporation's riverside road project is likely to gain speed after the civic standing committee approved a proposal to start the land acquisition process. According to civic officials, the administration had approved the 22km Shivane-Kharadi riverside road in 2007 to connect the eastern and western parts of the city. When completed, the road will be a vital link between the Mumbai - Bangalore and Pune-Ahmednagar highways.



# New route between Pune and Kolhapur will reduce travel time

According to a report prepared by Rail Parishad, a new route between Pune and Kolhapur based on the principles of Konkan Railway could cut travel time to less than four hours. The report states that instead of laying additional track on the existing rail line between the two western Maharashtra cities, a new route could drastically bring down the journey duration from the current time of 8.40 hours.

#### Railway projects get a boost with additional terminal at Hadapsar

The rail budget gave a good push to the rail infrastructural projects in the city with an allotment of as much as Rs 60 crore for creation of traffic facilities. The budget has allocated Rs 23 crore for creation of additional terminal at the Hadapsar Railway Station as well as Rs 38.07 crores for remodeling of Pune Railway Yard.

#### PMC offers 10% rebate on property tax to housing societies
