INTRODUCTION

The Mumbai real estate market is undoubtedly one of the most expensive ones, not only in India but also across the globe. The residential transactions in the city account for a major chunk of the uber-luxury housing market in India.

Multiple transactions priced above Rs 15 Crore were registered in Mumbai during the Jan-Jun 2021 period. This indicated that there was an appetite for the luxury housing segment in the city despite the pandemic. The uptick in sales of these high-end properties was also fuelled by the stamp duty waiver extension that was available till March 31st, 2021.

THE STAMP DUTY IMPACT

The impact of the stamp duty waiver was clearly visible in the drastic drop in the number of transactions post March 31st, 2021.




